PROJECTS INCLUDE EROSION CONTROL, DEBRIS REMOVAL, BRUSH CUTTING, TREE PRUNING, BENCH AND RAIL PAINTING, PLANTINGS, AND THE RESTORATION OF BRIDGE EMBANKMENTS.
